## <u>Order</u>

On the hearing held on 18.09.2012, Hota'ble Ombudsman passed the order as reproduced below for information, necessary action and compliance:

"Hearing held. Discom presents papers relating to earlier dues settlement in permanent Lok Adalat in 2005 to show Kanchan Rai (Rani) is a persistent defaulter. However, K. No. is not mentioned in these papers. Both K. Nos. ........743 & ........322 are Kanchan Rai (Rani), name in Haiderpur village but the notice for transferring dues has gone to Shalimar Bagh.

Amit Yadav, who filed the petition in CGRF, and the appeal here, is not the person with the connections in his name. Hence, even if the case of Amit Yadav is upheld here the Discorn is free to proceed against Kanchan Rani (Rai).

In the circumstances Discom has decided to issue fresh notices, as per their records, ensure due service & given proper hearing to resolve the matter. In the event this case concerning the 2 K. Nos. ending in .......743 & .......322 can not be resolved till this solution. Both parties are free to approach any forum at any stage if the grievance persists, or arises affects.

Case is closed as infructuous".
